1. This registered cat/kitten has been sold as a PET. The final adult quality of cat/kitten for show cannot be guaranteed.
2. Cats/kittens will be spayed/neutered before one year of age. Upon breeder's receipt of vet verification of altering, purchaser will be provided registration papers.
3. Full price of said cat/kitten shall be paid in full before the release to the purchaser. The seller is not liable for cats/kittens lost or stolen after acceptance by the airline carrier. It is the responsibility of the purchaser to file a claim with the airline carrier if shipments are lost, damaged, or delayed resulting in sickness or mortality of the cat/kitten.
4. The cat will not be outdoors without enclosure or restraint (harness/leash) and the cat/kitten should not be declawed. Please talk with the breeder or your vet about alternatives.
5. Our basic health guarantee includes general health and freedom from internal parasites. The cat/kitten has been checked by our veterinarian at the time of the sale and is guaranteed to be in good health. This health guarantee extends for 72 hours after purchase. **Guarantee good until ____/____/____ at ____: ____ am / pm.** If any medical issues occur, the breeder will be contacted first before any other action is taken on the behalf of the purchaser.
6. There are no cash refunds unless the breeder makes the decision to do so. The breeder also has the right to refuse any and all medical costs incurred without preapproval from the breeder. A replacement cat/kitten maybe the other option. The replacement is for the cat/kitten only and will be given as soon as available, if such decision is made. Breeder will not be liable for shipping costs under any circumstances.
7. Personal checks are only taken for deposits, and there will be a \$50 charge for a bounced check. PayPal is preferred for deposit and can be used for final payment as long as breeder receives proof of PayPal payment prior to pick up. Money order, cashier's check or cash only at time of cat/kitten pick up.
8. Any breach of contract by purchaser and purchaser will pay a fee of \$500 to the breeder and cat/kitten will be returned to breeder at no cost. Purchaser is liable for any court costs and related charges, including attorney's fees that are associated with breeder's enforcing the terms of this contract. Any legal action will be brought in the country/city of breeder's residence.

We the undersigned consider this document legally binding. Deletions or additions to the sales agreement have to be initialed by both the breeder and the purchaser.
